# SIGMA TAU EPSILON

For the purpose of furthering the cause of accident prevention in and about the coal mines of The Union Pacific Coal Company, the first Greek letter Safety Honor Society known to the mining industry was organized at Rock Springs, Wyoming, on February 27, 1941.

The name of the Society, SIGMA TAU EPSILON, represents the three initial letters of the Greek words, SOTERIA TIME ETAIREIA, which, translated into English, reads, Safety Honor Association, Club or Brotherhood. Forty-three charter members were admitted to the Society at the Rock Springs meeting, and additional members will be added from time to time when qualified.



# RULES GOVERNING THE SOCIETY

# Requirements for Membership

The membership in SIGMA TAU EPSILON will be restricted to supervisory officials, who have attained a commendable standard of safety in the conduct of their work. The officials eligible for membership are:

Mine Superintendents

Mine superintendents who were in general charge of any certain mine which has won or in the future may win the Sentinels of Safety Trophy. Members qualifying under this section will not be privileged either to hold office or to vote.

Mine Foremen

Mine foremen who were in local charge of any certain mine which has won or in the future may win the Sentinels of Safety trophy, or who were in charge of a mine in which no lost-time accident was suffered for a calendar year. Members qualifying under this section will not be privileged either to hold office or to vote.

Unit Foremen

Unit foremen who have conducted a section or sections in any mine or mines for three consecutive calendar years, without a lost-time accident suffered by any employe working under their direction. Unit foremen who have conducted their section or sections without a lost-time accident for the three preceding calendar years, will be eligible to membership in the Society. Members qualifying under this section will be privileged both to hold office and to vote.

Outside Foremen Outside foremen who were in charge of the outside men employed in any mine or group of mines to whom no lost-time accident occurred for a period of three consecutive calendar years, Outside foremen who have conducted their foremanship without a lost-time accident during the three preceding calendar years, will be eligible to membership in the Society. Members qualifying under this section will be privileged both to hold office and to vote.

Proof of eligibility for membership will be taken from the payroll and accident records of The Union Pacific Coal Company, certified to by the Company's Auditor and the Safety Engineer or General Manager. No officer other than those covered by the above four sections will be eligible for membership in the Society.

Proof of Eligibility

General officers of The Union Pacific Coal Com. General Officers pany will not be eligible to membership in the Society, but any member who may be advanced to by promotion the office of President, Vice President of Operation, General Manager, General Superintendent, Chief Engineer, or Safety Engineer, will be privileged to retain his membership in the Society with out right to hold office or to vote.

No honorary membership shall at any time be established by the Society.

Honorary membership

There will be elected at the first quarterly meeting of each year, a President, a Senior and a Junior Vice President and a Secretary, who will conduct the affairs of the Society in a manner approved by the membership, fifty per cent of the members who are in the employ of The Union Pacific Coal Company constituting a quorum at any meeting.

Election of Officers

Nominations for each office, not to exceed five in number, may be made from the floor, each nomination to receive a second. When all nominations are completed the President or other presiding member will appoint two tellers who will proceed to canvass the votes of the members present by written ballot. On the completion of the count by the tellers, the presiding officer will announce the names of the officers elected for the ensuing year.

Officers, how elected

The duties of the President (or in his absence a Duties of Officers Vice President), will be to arrange a suitable program for each regular and special meeting, to preside over same, and to use his best effort to inspire and promote the work of accident prevention. The Secretary will maintain an accurate record of all proposed members, with qualifications and date of admission to membership, and in addition will maintain a roster of membership and keep a full record of the transactions of all regular and special meetings. No dues will be collected from members and

no expenses will be incurred except with the approval of the General Manager of The Union Pacific Coal Company.

Meetings, When held

Regular meetings of the SIGMA TAU EPSI-LON will be held quarterly in each year at Rock Springs in the months of February, May, August and November, at a time and place designated by the President.

Special meetings may be called by the President or in his absence, by a Vice President when necessity requires same.

Non-employe members

Members who leave the employ of The Union Pacific Coal Company will retain their membership but will not be privileged to hold office or to vote.

Committees on Safety recommendations

There will be appointed by the President at the first quarterly meeting in each year, certain committees on safe practice recommendations, each of whom will elect a Chairman and a Secretary. Each committee will diligently study accident prevention methods, making due report to the Society for approval, amendment or disapproval of their recommendations; all approved recommendations to be submitted by the Secretary to the Safety Engineer for the consideration of the management of The Union Pacific Coal Company. All committee appointments will be for one year and all vacancies will be filled by the President of the Society. The Safety Engineer will deliver promptly to the proper committee chairman, a statement of all accidents that occur within and outside the mines for such recommendations as the certain committee may submit. It will be understood that the real work of the several committees is to observe bad practice, making recommendations regarding same, thus anticipating and attempting to prevent accidents.

Society Emblem A suitable emblem to be worn by each member of the Society will be furnished by The Union Pacific Coal Company, upon which will be engraved the name of the member and the year of his admission to the Society.

# COMMITTEES ON SAFE PRACTICE

#### 1949

The promotion of safe practice is primarily the function of the Company's supervisory officials, and accident prevention can best be accomplished by anticipating and removing the cause of accidents before they occur. To that end SIGMA TAU EPSI-LON will maintain ten standing committees whose duty will be to observe bad conditions and bad working practices, making recommendations to the management for the correction of same.


