Referring to Accounting Department Bulletin Mo. G-105-2 dated February 18, 1955, which provides that officers heretofore classified under Group (A) in Bulletin G-105 of August 1, 1944, shall hereafter furnish a limited detail in support of personal expense accounts.

These instructions, which are effective March 1, 1955, were issued to meet certain new requirements of the Interstate Commerce Commission.

Since under the instructions in General Auditor's Bulletin of August 1, 1944 officers in both Groups (A) and (3) have been required to keep a supporting record of expenses incurred, in order to make a reasonable substantiation of their expense accounts if and when requested, the new procedure should not add any appreciable burden, and I will appreciate it if you will see that these instructions are properly observed by those concerned.

Detail of Personal Expense Accounts

TO ALL CONCERNED:

Effective at once:

- 1. All previous instructions pertaining to the detail of personal expense accounts are canceled and superseded by the instructions herein which have been authorized by the President.
- 2. The detail to be submitted by officers and employes in support of personal expense accounts submitted for reimbursement should be to the extent provided, for the applicable group, under which the individual should be classified as follows:
 - (A) OFFICERS WHO INCUR EXPENSES IN THE SERVICE OF THE COMPANY FOR WHICH REIMBURSEMENT MAY BE MADE WITHOUT A SHOWING OF DETAIL:

Vice Presidents, General Managers and general officers who are heads of departments (principals), Executive Assistants to President and such others as the President may from time to time authorize, are not required to file detail of their personal expenses incurred in the service of the company.

(B) OFFICERS AND EMPLOYES WHO INCUR EXPENSES IN THE SERVICE OF THE COMPANY FOR WHICH REIMBURSEMENT MAY BE MADE WHEN ACCOMPANIED BY LIMITED DETAIL:

Any officer or employe not coming within Group (A), whose salary is \$6,000 per annum or more, and such others as the President may from time to time authorize, will be required to file limited detail of personal expenses incurred in the service of the company. Such limited detail should consist of the following separations: hotel bills, meals, railroad fares, Pullman fares, automobile mileage, other large or unusual expenditures with explanation thereof, and incidentals, to which others may be added, according to the nature of the assignment, by the heads of departments.

(C) OFFICERS AND EMPLOYES WHO WILL BE REQUIRED TO SUPPLY FULL DETAIL AS CALLED FOR ON FORM 137, "BILL PAYABLE FOR PERSONAL EXPENSES."

Any other officer or employe whose salary is less than \$6,000 per amum will be required to file full detail as called for on Form 137.

- 3. Regardless of the foregoing authorizations, the heads of departments may require officers reporting to them, who are hereby classified in group (B), to furnish additional detail or the full detail as required in group (C).
- 4. It should be understood that officers in groups (A) and (B) shall be prepared to make a reasonable substantiation of their accounts if and when required.
- 5. Practices not in conformity with the foregoing should be corrected to conform therewith as of the effective date hereof.
