Your letter of August 14, file 709-3, enclosing draft of proposed corporate history of The Union Pacific Coal Co., prepared by Mr. Rawlings and others. The draft has been submitted to Mr. Livingston who advises that he has no changes to suggest or comments to make.

At the request of Mr. Webb, the address of Frederick L. Ames, under Organization, has been changed from North Eastern, Mass., to North Easton, Mass. On sheet 2 of Expansion and Development, I suggest that 3½ Mine, Hanna, be included under opening of new mines near the bottom of the sheet. According to the records in the Engineering Department preliminary work on the opening for this new mine was started in October 1911. The first coal reported as mined from this location was July 1912. Prior to July cost of opening this mine was charged on Form 168 under No. 3 Mine as "Unusual Expenses". No. 3½ Mine after having been operated by the Company for several years was leased to John W. Hay, Rock Springs, on October 1, 1920, and subsequently closed July 11, 1925.

While some of the Coal Company accounts were kept in the New York office, the Western General Office was maintained in Omaha from the time the Coal Company was organized in 1890 until September 10, 1906, when the General Offices were moved to Cheyenne, Wyoming. The offices were moved farther west to Rock Springs, Wyoming, starting in May 1919 and extending through November 14, 1921, as suitable quarters could be obtained.

On sheet 5 of Expansion and Development, I would suggest that the information contained in paragraph showing distribution of electric energy be enlarged upon so as to include Reliance, Stansbury, Winton and Superior among the locations to which electrical energy (especially for residential purposes) is being distributed by the Southern Wyoming Utilities Company, effective January 1, 1948. The franchise held by the Southern Wyoming Utilities

Company for distribution of electric energy, water, etc., was extended effective May 1, 1948, to include Hanna and vicinity in Carbon County, Wyoming.

The additional information shown above may or may not be of value to you in completing the history. I have examined the information shown in the final draft and have no further suggestions to make. In my opinion the information to be incorporated in the corporate history of The Union Pacific Coal Company will be interesting and valuable to future executive and operating officers charged with the responsibility of operating the properties.
